Dear Mayor Jarratt and City Council members:

You currently have a rogue employee who is in a position of influence within the city. I bring this to you in high hopes and with cautious optimism that you are unaware of what is going on with this rogue employee and therefore would in no way support or condone such egregious behavior.

When a small group of misfits go rogue and start behaving like Weimar German brownshirts because they don't like the result of a fair and legally-conducted election, our entire system of Constitutional government is placed in dire jeopardy. Needless to say, our way of life is being challenged daily and the jury is out regarding where this ends -- at the local, state and national levels.

As you may recall, on Thursday, February 2, 2023, the Hood County offices were officially closed due to icy conditions on the roads. Be that as it may, at about 12:45 pm, I traveled to my office, which is located in the old historic courthouse. Upon arrival, I found that the steep steps leading up to the west door of the courthouse were iced over. I assessed that trying to go up these steps in that condition was not a good idea, so I went back out to my truck to see if I had a hammer or something I could use to break up the ice. I did not. I then called a friend, Mr. Nathan Criswell, who I knew was at his office, and asked him if he had a hammer by any chance. He replied in the affirmative and offered to bring it over to help me break up the ice. He arrived a few minutes later and he and I proceeded to break up the ice on the steps.

Little did we know that someone was stalking us at that very moment. That someone goes by the moniker "Leroy Phoenix", a fake Facebook character who is a denizen of the Facebook page entitled the "Hood County Killer Whale Group." I attach for your review a photograph "Leroy Phoenix" posted on February 2, 2023, along with a nearly full-page

diatribe speculating as to what Mr. Criswell and I might have been doing at the courthouse at that time. (See Exhibit "A", attached). The photograph was taken on February 2, 2023, at around 1:10 pm to 1:20 pm.

Prior to this time, the cartoon character "Leroy Phoenix" had posted numerous long-winded rants attacking me, Mr. Criswell, Katie Lang, and numerous other elected officials, including Mayor Jim Jarratt. (See Exhibit "B", attached).

On Friday, February 3, 2023, Mr. Criswell went down to the Sheriff's office and filed a stalking complaint and police report regarding "Leroy's" harassing acts. At that point in time, all that was suspected was that a large black pickup had been seen about the same time all this took place. We did know, however, that "Leroy Phoenix" had engaged in harassing behavior prior to this on more than one occasion.

Upon further investigation of surveillance cameras on the square, we later discovered that there was indeed a large black pickup involved in this incident. (See Exhibit "C", attached). The images on Exhibit "C" depict a black truck that was headed west on Pearl, then turned north on Houston, and which was positioned exactly at the same time (around 1:10 pm and 1:20 pm) Mr. Criswell was coming down the steps of the courthouse. As you can further see, there are many details regarding this black truck that single it out from other black trucks.

Based on surveillance cam footage and other resources, we were able to obtain the license plate number of this pickup truck – Texas tag, SCW-6972. Upon running ownership connected with this plate number, it turns out that the truck belongs to your city attorney, Mr. Jeremy SoRelle, a/k/a Leroy Phoenix.

Why would the City of Granbury's attorney be stalking another elected official? Why does he utilize a fake Facebook character to carry out his attacks? Who is "pulling his strings" to have him carry out such a clandestine operation against political opponents?

Currently, I am trying to decide what legal action I might want to pursue, if any, for being stalked by the City of Granbury's attorney. Stalking and harassment allegations may be advanced under the Texas Penal Code as a criminal matter as well as the Texas Civil Practices & Remedies Code as a civil matter. Surely the "powers that be" within the city do not advance or condone this type of activity. I wonder whether Mr. SoRelle is dedicated to the highest ideals of honor and integrity as it relates to his public relationships? I would hope that a city attorney would refrain from entering into any activity which may be in conflict with or give the appearance of conflict with the interests of the citizens of Granbury or which would prejudice his ability to carry out objectively his duties and responsibilities. Whatever the case, Mr. SoRelle, a/k/a Leroy Phoenix, sets a dangerous precedent with his off-the-reservation antics. Such behavior could taint future efforts for the city and county to work together on such issues as Hwy 377, wastewater, stormwater and other infrastructure concerns.



Thank you for your attention to this. Please feel free to call any time if you have any questions or wish to discuss.


