Narrative

Information report per Tyler Johnson #121

On Friday, February 3rd, 2023 at approximately 11:26 a.m. I Deputy Johnson #121 and Deputy Burge #152 responded to a walk-in at the Hood County Sheriff's Office on a report of harassment.

Myself and Deputy Burge met with Nathan Andrew Criswell. He stated that he felt like someone was watching him outside the courthouse on February 2nd, 2023 while he was breaking ice off the steps with Dave Eagle at approximately 1:00 p.m. Nathan stated he left the courthouse at 1:15 p.m. and saw a black Chevy pickup truck with dark tint on it and other noticeable accessories like a toolbox and running boards. Nathan then said that there was a fake Facebook account with the name of Leroy Phoenix that posted a picture of him walking out of the courthouse. Nathan said he took pictures of the pickup truck with no readable license plate.

At 4:00 p.m. Nathan said the fake Facebook profile posted a picture of him exiting the courthouse on the Hood County Killer Whale public Facebook page. He said that this Facebook profile Leroy Phoenix has been harassing him for almost one year along with Dave Eagle, Katie Lang, Melanie Graft, and many others and that he is in fear for his safety. Nathan filled out a witness statement and gave it to Deputy Burge and I.

Supplement Report per Deputy Stephen Burge #152

On Friday, February 3, 2023, at approximately 11:26 a.m., Recruit Johnson #121 and I, Deputy S. Burge #152 (2 man unit), responded to the lobby of the Sheriff's Office located at 400 Deputy Larry Miller Drive in reference to a walk-in report of harassment.

Upon arrival we spoke with Nathan Andrew Criswell who reported he felt he was being harassed. Nathan reported on Thursday, February 2, 2023 at approximately 12:46 p.m. he was contacted by David "Dave" Robert Eagle who stated there was ice on the courthouse stairs and requesting a hammer to break the ice so Dave could enter the building.

Nathan agreed to meet him there and assist in removing the ice. Nathan stated he arrived at the courthouse at approximately 1:00 p.m. and was approached by Dave. Nathan handed him the hammer before exiting his vehicle to assist. The two broke up then removed the ice after which they retreated to Dave's office for approximately 15 minutes.

At approximately 1:15 p.m., Nathan exited the courthouse and felt as though he was being watched. Nathan observed a black in color either GMC or Chevy heavy duty (HD) pickup truck nearby. Nathan was unsure of the model but believed it to be either a 2500 (3/4 ton) or a 3500 (1-ton). The vehicle was described as having several identifying characteristics including dark tint, running boards and a toolbox. Nathan was unable to gather unique identifying information such as a license plate number.

At approximately 4:30 p.m. a Facebook post was uploaded to the "Hood County Killer Whale Group" by "Leroy Phoenix" giving an account of the actions taken by Nathan and Dave. I later located the post which reads:

"Hood County has been closed since noon Monday.

Why would an ineligible Commissioner make such an effort to be in the Court House on the Days when it is closed? He does not care to be there when the weather is decent or perfect, so why on days when it is dangerous to drive? He probably has no insurance and if he does it is probably only liability.

How does Nathan Criswell have access to County Offices that are closed?

He was seen at 1pm today rolling his window down so Dave Eagle could reach in and grab something from inside his car. Then He exits the vehicle and follows Dave Eagle into a closed County Building, and is later seen witnessed exiting the building alone?

People need to know what is going on in that building when no one is suppose to be there. Did he try do anything to any of the offices after he exited Dave Eagles office on the 3rd floor?

My bet is Dave is manufacturing some kind of fake controversy to distract from all of the illegal things going on. That could be a lot of things and it could be him manufacturing a cover up for the Executive Committee Finances that they will not let a certified independent auditor review. He did the same thing manufacturing a fake utility bill trying to quite the people who know he had zero water or electricity in the house he is lying about living at.

You will notice that I do not say my opinion is he does not live there. I know for a fact he does not live there and never has.

That is the whipping post boy exiting the building, that technically is not a public building because it was ordered closed."

Nothing in the post is directed to Nathan or Dave and does not appear to be obviously threatening. Based on the description of the post Nathan provided at the time I advised the post did not sound threatening and there was no expectation of privacy protecting either Nathan or Dave from have their picture taken or shared. Nathan was advised this post and his statement would be recorded in an information report in the case an offense was committed in the future.

In Nathan's statement he advised that similar posts and threats were made referencing others including Dave Eagle, Katy Lang and Michael "Mike" Lang. Each person included in these posts are involved in local politics and many of which are believed to be associated with "The Blue Shark Show", a media organization that often records media of a political nature. "Hood County Killer Whale Group" appears to be a similar organization with differing political views than that of "The Blue Shark Show." In his statement, Nathan reports he suspects three individuals of being linked to the alleged misconduct to include Michael "Mike" Davis, Zachary Maxwell and Charles Nangle.

Harassment - PC 42.07 states:

- (a) A person commits an offense if, with intent to harass, annoy, alarm, abuse, torment, or embarrass another, the person:
- (1) initiates communication and in the course of the communication makes a comment, request, suggestion, or proposal that is obscene;
 - (2) threatens, in a manner reasonably likely to alarm the person receiving the threat, to inflict bodily injury on the person or to commit a felony against the person, a member of the person's family or household, or the person's property;
 - (3) conveys, in a manner reasonably likely to alarm the person receiving the report, a false report, which is known by the conveyor to be false, that another person has suffered death or serious bodily injury;
 - (4) causes the telephone of another to ring repeatedly or makes repeated telephone communications anonymously or in a manner reasonably likely to harass, annoy, alarm, abuse, torment, embarrass, or offend another;
 - (5) makes a telephone call and intentionally fails to hang up or disengage the connection;
 - (6) knowingly permits a telephone under the person's control to be used by another to commit an offense under this section;
 - (7) sends repeated electronic communications in a manner reasonably likely to harass, annoy, alarm, abuse, torment, embarrass, or offend another; or
 - (8) publishes on an Internet website, including a social media platform, repeated electronic communications in a manner reasonably likely to cause emotional distress, abuse, or torment to another person, unless the communications are made in connection with a matter of public concern.

Based on the law as written it does not appear an offense was committed as (1) the communication of the post was not made specifically to the complainant (2) there is no threatening language contained within the post (3) no false report was made in the post (4-6) no telephone communication was attempted (7) electronic communication was not attempted to the complainant by the person making the post and (8) the communications made are believed related to a public matter of public concern (local politics). As such, this report is being written for informational only.
