*Granbury Independent School District* announced its policy today for providing free and reduced-price meals for children served under the attached current income eligibility guidelines. Each school or the Administration offices have a copy of the policy.

Starting on *July 18*, 2022, *Granbury ISD* began distributing letters to the households of the children in the district about eligibility benefits and any actions households need to take to apply for these benefits. Applications are available on the GISD website @ www.granburyisd.org at this time.

## Criteria for Free and Reduced-Price Meal Benefits

The following criteria is used to determine a child's eligibility for free or reduced-price meal benefits:

Income: Household income that is at or below the income eligibility levels

Categorical or Automatic Eligibility: Household receiving Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF); or Food Distribution Program on Indian Reservations (FDPIR)

**Program Participant:** Child's status as a foster child, homeless, runaway, migrant, or displaced by a declared disaster **OR** Child's enrollment in Head Start or Even Start

**Income Eligibility** 

For those households that qualify for free or reduced-price meals based on income, an adult in the household must complete a free and reduced-price meal application and return it to *GISD Child Nutrition 217 N. Jones Street Granbury, TX 76048*. Those individuals filling out the application will need to provide the following information:

- 1. Names of all household members
- 2. Amount, frequency, and source of current income for each household member
- 3. Last 4 digits of the Social Security number of the adult household member who signs the application or, if the adult does not have a social security number, check the box for "No Social Security number"
- 4. Signature of an adult household member attesting that the information provided is correct

## Categorical or Program Eligibility

*Granbury ISD* is working with local and state agencies to identify all children who are categorically and program eligible. *These households will not need to complete an income application*.

## **Determining Eligibility**

Under the provisions of the free and reduced-price meal policy *Davelyn Davis*, *CN Secretary and Application Specialist for GISD* will review applications and determine eligibility. Households or guardians dissatisfied with the Reviewing Official's eligibility determination may wish to discuss the decision with the Reviewing Official on an informal basis. Households wishing to make a formal appeal for a hearing on the decision may make a request either orally or in writing to *Emmett Whitefield*, *GISD Chief Financial Officer at 817.408.4022 or emmett.whitefield@granburyisd.org*.

## **Unexpected Circumstances**

If a household member becomes unemployed or if the household size increases, the household may complete a new application. Such changes may make the children of the household eligible for benefits if the household's income falls at or below the attached current income eligibility guidelines.
